The Welsh Ministers propose to carry out an improvement of the A40 trunk road between Llanddewi Velfrey and Penblewin Roundabout. In connection with this proposal the Welsh Ministers have published draft Orders under the Highways Act 1980. To ensure that those people most directly affected by a scheme are aware of the proposals we arrange for information about it to be delivered to those properties closest to the proposed new road. These properties are generally those within 100 metres of the scheme, but others are included where considered appropriate. Your property has been identified as one which should receive this information, so please find enclosed a copy of the associated Public Notices, Explanatory Statement, Scheme Assessment Report and Non-Technical Summary of an Environmental Statement.

As you will see from the enclosed Public Notices, the draft Orders, associated plans and the Environmental Statement are available for public inspection at several deposit locations.

A public exhibition of the draft Orders will also be held on 15th August and 5th September 2019, the details for which are included in the enclosed Public Notice.

I would ask that if you are a tenant of the property that you inform the owners of the receipt and contents of this letter, further copies of which may be obtained from this Office.
