**NOTICE IS HEREBY GIVEN** that a Public Local Inquiry in connection with the forthcoming Public Inquiry into the above named draft Orders will be held by Mr A. McCooey (BA (Hons) MSc MRTPI), an Independent Inspector appointed for the purpose by the Welsh Government on nomination by the Planning Inspectorate, commencing at 10:00 am on 10 March 2020 at the Llanddewi Velfrey Village Hall, Glan Preseli, Llanddewi Velfrey, Pembrokeshire SA67 7PG to hear objections and representations from statutory objectors (as defined in The Highways (Inquiries Procedure) Rules 1994 and The Compulsory Purchase by Ministers (Inquiries Procedure) (Wales) Rules 2010) and from any other persons having an interest in the subject of the draft Orders, and also, at his discretion, to hear representations from any other person who may desire to appear and be heard.

Any person attending the Inquiry is welcome to use the Welsh Language.

A copy of all such correspondence is normally kept in the Public Inquiry and is open to inspection.

If you have not already done so and wish to submit an alternative to the published proposal you are requested, in accordance with paragraph 19 of Schedule 1 to the Highways Act 1980, to do so by no later than 25 February 2020, but sooner if possible. This will enable the Welsh Government to "engineer" the proposal to accommodate the appropriate road standards and to circulate it to those who may be affected.
