THE WELSH MINISTERS (THE LONDON TO FISHGUARD TRUNK ROAD (A40) LLANDDEWI VELFREY TO PENBLEWIN IMPROVEMENT) COMPULSORY PURCHASE ORDER 201-

I refer to the Welsh Government's letter dated 17 October 2019 informing you that the Welsh Ministers have decided to hold a Public Local Inquiry into the above Orders. The Inquiry will be held by Mr A. McCooey (BA (Hons) MSc MRTPI) an Inspector appointed for the purpose by the Welsh Government on nomination by the Planning Inspectorate.

PRE-INQUIRY MEETING

The Inspector will hold a Pre-Inquiry Meeting on Wednesday 15 January 2020 at the Llanddewi Velfrey Village Hall, Glan Preseli, Llanddewi Velfrey, Pembrokeshire SA67 7PG, starting promptly at 10.00am. Formal notice of the Pre-Inquiry Meeting will be published by the Welsh Government in advance of the Pre-Inquiry Meeting. I should explain that the purpose of this meeting is not to hear any evidence but to help the Inspector and all interested parties to prepare for the Inquiry. The Inspector will also set out how and when evidence is to be prepared and presented by all parties. The Inspector will outline how the Inquiry will be conducted and the procedures to be followed. If you are unable to attend the Pre-Inquiry Meeting, this will not prevent you from appearing at the Inquiry itself, which is planned to commence on 10 March 2020. However, it may be of considerable help to you to hear the Inspector's address at the Pre-Inquiry meeting and to get any queries or concerns about the process cleared up as an aid to both your submission of evidence and an understanding of how the Inquiry itself will be run.

I enclose a copy of the Notice announcing details of the Pre-Inquiry meeting for your information. Please see link to the Welsh Government document 'Public Inquiries into Road Proposals', this may be referred to at the Pre-Inquiry Meeting and explains in simple terms the arrangements and procedures for public Inquiries held into road proposals (<https://gov.wales/understanding-public-inquiries-road-proposals>).

If you have any special requirements for your attendance at the Pre-Inquiry Meeting, please let me know.

Any person wishing to speak at the Inquiry in the Welsh language is welcome to do so.

I would advise that the Public Inquiry will be conducted in accordance with The Highways (Inquiries Procedure) Rules 1994 and The Compulsory Purchase (Inquiries Procedure) (Wales) Rules 2010.
